SIGNIFICANT ACTIVITIES

2003 – 2004 Billing

- **Forty-two accounts**, including Canada, are being billed monthly for the 2003 – 2004 period.
- Nine of seventeen Caribbean countries have paid in full; one country is paying monthly.

Billing and Collection Solicitation

- The solicitation was released on January 30, 2004; responses due March 8, 2004; contract award in April.
- Six companies, including NBANC, submitted questions. Several were billing and collection agencies; one was the Canadian B&C Agent.
- NBANC submitted its bid on Friday, March 5, 2004.

Request for Reimbursement

- The FCC OIG requested additional documentation in support of the NBANC October 2003 \$58Thousand request for reimbursement for additional work performed between October 2002 and December 2003. We plan to submit it on March 12.
